It is intended that at least two volumes of the journal will appear each year. Intending contributors should submit two copies of manuscripts to the Editor-in-Chief (A P Street), the Managing Editor (A J Rahilly) or any one of the Associate Editors (E J Billington, D M Donovan, J N Holt or S Oates-Williams), all of whom are at the Editorial Office of the Australasian Joumal of Combinatorics, Department of Mathematics, The University of Queensland, 4072, Queensland, Australia. The journal is produced using a photooffset process. Because of this it is most important that authors submit manuscripts typed so as to occupy a 6 inch $\times 9$ inch ( $152 \mathrm{~mm} \times 229 \mathrm{~mm}$ ) rectangular area centred on each page. Authors are also urged to submit papers the title page of which exhibits the following order: title, author/s, affiliations, abstract, followed immediately by the body of the paper.

# MINUTES of the Annual General Meeting held on 4 December 1990 <br> at the Sixteenth Australasian Conference on Combinatorial Mathematics and Combinatorial Computing at Massey University Palmerston North, New Zealand 

C H C Little (Director) declared the meeting open at 7.00 pm , with 29 people (on average) present.

1. Welcome: The Director welcomed all chose present.
2. Apologies:

E Dawson, M Conder, L Foulds, D Street, W Wallis.
3. Minutes of the $\mathbf{1 9 8 9}$ AGM:

Minutes of the previous AGM (Brisbane, 13 July 1989) were circulated.
MOVED: That the minutes be adopted.
(McAVANEY/NEUMANN, carried nem. con.)
4. Matters arising from the minutes:
(a) Item 10: Mocion (previously tabled) to change the constitution.

The following motion was tabled in 1988 and 1989 for consideration at the 1990 AGM:
Notice of Intention to Change the Constitution that, in the item "Termination", the phrase
"to the Australian Mathematical Sociery"
be changed to
"equally to the Australian Mathematical Society and the New Zealand Mathematical Society."

Derek Holton mentioned that the change was motivated as an acknowledgement of the funding provided by the NZMS for CMSA conferences held in New Zealand. Jennie Seberry offered further support for the motion, noting that the AMS had recently turned down a request for funding for the next conference. Given that the CMSA was not likely to ever disappear, Ralph Stanton supported either the current or proposed wording.

MOVED: That the motion be approved.
(LITTLE/HOLTON carried nem. con.)
(b) Other: all other matters arising are dealt with elsewhere in the Minutes.
5. Director's Report:

The Director reported that he had quite literally interpreted his role, and thanked the various people to whom he had delegated responsibility in the organization of the Conference. He also acknowledged the secretarial support of the Department of Mathematics and Statistics, Massey University, the financial sponsorship of the Royal Society of New Zealand, funding support from the New Zealand Mathematical Society, Bennetts University Book Centre Ltd, Advantage Computers Ltd, and the British Council (which contributed towards the airfare of Douglas Woodall). All the invited and contributing speakers also deserved special thanks.

The Director highlighted two recent developments in Australasian Combinatorics: the establishment, by Anne Street of the Australasian Journal of Combinatorics, and the initiation of the booklet series (edited by Kevin McAvaney) on various aspects of combinatorics (as a means of generating a continuing source of income for the CMSA). He also suggested the formation of a Publications Committee to have an oversight and coordination role for the booklers, and also a position of Newsletter Editor.

MOVED: That the Director's Report be received.
(CHAIR, carried nem. con.)
MOVED: That a Publications Committee be formed and charged with general oversight of the Society's publishing activities.
(CHAIR, postponed until consideration of item 8)
MOVED: That the position of Newsletter Editor be created.
Much discussion ensued. Jennie Seberry mentioned that the logistics of liaising with someone else so close to the next Conference would be difficult, and that the use of Research Assistant at that time would be more appropriate. Charles Little maintained that the Newsletter deserved more attention than a Conference Organising Commitree could give it. Kevin McAvaney asked if it was envisaged that the Newsletter become like the AMS Gazette, whereby assistance could be shanghaied to deal with, for example, "PhD theses", "preprints" and "visitors". Anne Street agreed, suggesting that if the Society had a President and Secretary the Director would be free to deal exclusively with the Conference. She further foreshadowed the idea of creating the position of a Membership Secretary.

Jennie Seberry took the opportunity of asking for suggestions for what should be in the Newsletter. Charlie Colboum noted that it was often difficult to find out what went on at a Conference if one was unable to attend; a short report in the Newsletter, including E-mail addresses of the list of participants, would be useful. Derrick Breach spoke against the motion, whilst Warwick de Launey spoke for it, seeing advantages in having one person responsible for all parts of the job. He added that the contents of the Newsletter be examined to determine if one was actually necessary. It was thus decided to

MOVE: That the motion be deferred until the next AGM (PALMER/STREET, carried).

## 6. Treasurer's Report:

In the absence of Ed Dawson, Helen Gustafson presented the Treasurer's Report, with figures quoted in Australian dollars. Bemhard Neumann pointed out that the report was, according to the Society's Constitution, required for the past calendar year, not financial year, and suggested that the incoming Organising Committee clarify the discrepancy. Several possibilities for changing future report dates were considered, in order to cover the differing financial years in Australia and New Zealand, but no consensus was reached. Jennie Seberry suggested that either an unaudited stacement be presented to the next AGM, or a six-monthly report be presented.

MOVED: That the Treasurer's Report be accepted. (COLBOURN/SEBERRY, carried nem. con.)

## 7. Matters arising from the Treasurer's Report:

(a) Subscriptions

A convoluted sequence of motions and amendments were put, interspersed with procedural debate. Major points of discussion included: Ralph Stanton noted that current payments were out of synchronization because of the timing of the present conference. Warwick de Launey mentioned that dues were sometimes included in conference fees, but Charles Little wamed that this was unconstitutional.

MOVED: That the subscription dues remain at \$A10.
(BREACH/BLLINGTON, carried (eventually))
AMENDMENT: That payment be for the period January 11990 - December 311990. (STANTON/COLBOURN, carried).

Included in the discussion on the Amendment, Charlie Colboum advised that fixed payment periods were useful for overseas members. Jennie Seberry proposed that, if the dues were a clearly marked portion of the Conference Fee (à la the Australian OR society), there should be no (constitutional) problem. Bernhard Neumann suggested that volunteers (with published addresses) in New Zealand, Canada and the United States collect fees from local members and forward them in bulk, to reduce bank charges.

MOVED: That Jennie Seberry collect fees for 1990, plus fees for 1991 (for those who choose to do so) at this conference, and that the meeting instruct her to remit the funds to the Treasurer by January 15, 1991.
(SEBERRY/NEUMANN, carried).
AMENDMENT: That \$A5 be paid now (for 1990) and \$A10 for 1991. (HOLTON/McKAY, lost).

SECOND AMENDMENT: That \$A10 be paid for 1990 and \$A10 be paid for 1991. (STREET/SEBERRY, carried).

As clarification for the Treasurer, it was decided to, in future, report the dates at which members made payments to save partial-year "catch-up" problems.

## (b) Support for the Australian Journal of Combinatorics:

Warwick de Launey requested the publication details of the Journal. Anne Street replied that there were 50 subscribers, to whom the cost was \$A50 per year (\$A.25 per volume); this price was needed to cover the cost of producing 300-350 copies. $\$$ NZ20 had been included in the present conference's registration fee towards the production costs of the Proceedings. Anne Street noted that the University of Queensland Mathematics Department subsidized costs, and that there were few institutional subscribers.

MOVED: That the society contribute \$A1000 to the Australian Ioumal of Combinatorics (in addition to the fees already collected).
(SEBERRY/NEUMANN, carried nem. con.).
Anne Street will provide a report on the financial status of the Journal for the next AGM.

## (c) Life Membership and Cost:

Because of lack of information, it was decided to ask for recommendations at the next AGM. Ralph Stanton advised that the "usual" cost of life membership was $12 \times$ the annual membership fee.

MOVED: That this item be deferred to the 1991 AGM.
(NEUMANN/BREACH, carried nem. con.)

## (d) Proposal for a Membership Secretary

MOVED: That the position of Membership Secretary be created.
(STREET/SEBERRY, carried nem. con.)

## 8. Booklet Editor's Report:

Kevin McAvaney indicated that two booklets were under recent consideration:
"Three Principles of Combinatorics" (for which a revised version is being refereed).
"Combinatorial Aspects of Block Designs" (rejected because of length).
Further titles in the series are being sought, and should be forwarded to the Editor in $\mathrm{T}_{\mathrm{E}} \mathrm{X}$, preferably electronically, to reduce the resources required for rekeying.

MOVED: That the Booklet Editor's Report be received.
(HOLTON/BREACH, carried nem. con.)
Referring to the Director's first Motion (Irem 5), Kevin McAvaney stated that he perceived the Society Executive as his Committee, and saw no need for a special Publications Committee. Further discussion ensued regarding the general policy for the Bookler Series, and the difficulty in obtaining manuscripts for it. Guidelines as follows were formulated:

1.     - A theme from within the area of Combinatorics with the form of, for example, a review of a topic, a collection of problems or an annotated bibliography.
2. 30-50 pages, reasonably self-contained.
3. Aimed at the graduate/upper level undergraduate market.
4. Acceptable standard of writing and content.

The Director's original motion of forming a Publications Committee was LOST at this point.
9. Future Conferences:

MOVED: That future conferences be officially known by the year rather than the sequence number.
(CHAIR, lost 17-2).
MOVED: That future conferences be officialiy known by the year and the sequence number. (BREACH/GIBBONS, lost).

It was felt that retaining the sequence number was important to show the longevity of the Society and its Conferences, as this was useful in obtaining continued funding support.

Jennie Seberry then gave details of the 17th ACCMCC, to be held in Canberra, 8-12 July 1991. (See notice in February 1991 Newsletter).

9a. Election of Officers:

10. General Business:

Anne Street informed the AGM that pages 111-120 of Volume 2 of the Australian Journal of Combinatorics were missing in 9 copies as yet unaccounted for, and that copies of the Proceedings of the First ACCMCC were available for \$A5 each. It was noted that the CMSA does not currendy holi: a complete ser of ACCMCC Proceedings.

A motion (from Ralph Stanton) that there be a vote of thanks for the 16 th Conference Otganizing Commintee was received with acclamation.

The meeting closed at 9.11 pm .
