# The 19th Australasian Conference on <br> Combinatorial Mathematics and Combinatorial Computing 

The University of Adelaide<br>12-16 July 1993

The 19th ACCMCC will be held at the North Terrace campus of The University of Adelaide, Australia, from 12-16 July 1993. The North Terrace campus is located in the parklands surrounding the City of Adelaide, adjacent ot the central business and shopping district and close to the State Library, Festival Centre, Museum and Ant Gallery. The picturesque Torrens River, the Botanical Gardens and the Zoological Gardens are also nearby. The University was established in 1874 and currently has about 10,000 students, of who 2,000 are undertaking postgraduate study.

The conference will attempt to reflect the spread of interests of the delegates, in-corporating a special emphasis on finite geometry. As usual, graduate students are especially encouraged to attend and participate.

## Contributed Papers

A formal call for papers, including details of titles and abstracts, will be made in the next circular, to be sent early in 1993.

Papers from all areas of combinatorial mathematics and combinatorial computing will be sought. It is expected that presentation of a paper will be allocated $20-25$ minutes in the conference program, of which five minutes should be made available for questions from the audience and for movement between rooms.

## Accommodation

Single accommodation (with a very limited number of double rooms) has been booked at Lincoln College, a co-educational student residence at 45 Brougham Place, North Adelaide. It is an easy walk from Lincoln College across Adelaide's parklands to the University.

Adelaide is famous for its restaurants, many of which are within walking distance of both the University and Lincoln College.

## Social Programme and Entertainment

There will be an informal gathering and registration at Lincoln College in the late afternoon/evening of Sunday 11 July. The Organising Committee is planning a coach tour
to the Southern Vales wine-producing area in the afternoon of 14 July, with tasting and an opportunity to buy some of Australia's finest wines. As possible altematives, we can recommend a do-it-yourself walking tour of historic Port Adelaide with its fine Maritime Muscum and locally brewed beers, or a tram ride to Glenelg beach and a cappuccino at the Ramada Grand Hotel.

The conference dinner will be held on Thursday 15 July and a survivor's gathering is planned from the evening of Friday 16 July.

Introduction to elementary number theory, whose theme is the solution of diophantine equations.

Introduction to enumerative combinatorics, including Polya theory and an introduction to the finite operator calculus and the theory of combinatorial species.

# Minutes of the 18th Annual General Meeting of the <br> Combinatorial Mathematics Society of Australasia held on 7 July, 1992 <br> at the Eighteenth Australasian Conference on Combinatorial Mathematics and Combinatorial Computing at Curtin University of Technology, Bently W.A. 

The meeting started at 4.00 pm with Professor Cheryl Praeger and A/Professor Lou Caccetta sharing the chair.

1. Minutes of the 1991 AGM

These had been circulated in the April 1992 CMSA newsletter. It was moved from the chair that the minutes be accepted as read. Unanimously approved.
2. Matters arising from the Minutes

The only matter needing discussion was membership subscriptions, which was already included in the agenda. So discussions were postponed till then.
3. Reports
3.1 Directors' Report

The Directors' report was presented by Cheryl Praeger and Lou Cacetta, and was received. (It is printed in full in this Newsletter.)

### 3.2 Treasurer's Report

The Treasurer's Report was presented by Vijayan (in the absence of the Treasurer, Ed Dawson), and was received.

### 3.3 Secretary's report

The Secretary Vijayan presented his report, which was accepted unanimously. (This report appears elsewhere in this Newsletter.)

### 3.4 Booklet Editor's Report

The Booklet Editor Kevin Mc Avaney reported that at the moment one book is ready to be published. Two more are being refereed, one is being looked at a third time. Another one is back in the hands of the authors. There are a number of offers for more booklets. Two or three are promising.

The report was accepted unanimously.
4. Australasian Journal of Combinatorics

### 4.1 Editor's Report

The Editor Anne Street is happy with the number of papers being submitted to the Journal. Things are running smoothly, except that because of the premature death of Alan Rahilly,
the Managing Editor, the accounts are not up to date. A financial summary up to 31 May 1992 was tabled. (This summary appears elsewhere in this Newsletter.) The report was accepted unanimously, (Moved B.H. Neumann, seconded K. Mc Avaney.)

In further discussions Anne Street pointed out that the membership numbers are not strong only 70 currently - and need to be increased. A motion (moved Cheryl Praeger, seconded Anne Street) that the possibility of exchanging other Journals with AJC be explored, was carried unanimously.

## 5. Membership

The first question was about the membership fee. The treasurer in his report recommended no change though some felt that it should be increased so that the Joumal could be supported better. Wal Wallis raised the question of keeping a proper record of current members and sending reminders to those who are late with their payments. This would help to put membership fees on a realistic basis.

After some discussion, a motion that the membership fee for 1993 will remain the same as for this year, was carried. The financial status of members should be indicated on their copy of the newsletter.

Kathy Heinrich raised the question of Associate Membership of the Association. As there are no journals directly associated with the Association it was decided that there is no need for this category of membership.

The 1991 AGM had decided to postpone decision about Life Membership . Jenny Seberry introduced a motion:

A new category of membership called Life Membership will be created, and the fee for Life Membership will be fixed at 12 times the Ordinary Membership fee applicable at the time of joining as a Life Member.

The motion was seconded by Mike Palmer and carried unanimously.

## 6. Future Conferences

The venue of the 19th conference was confirmed as the University of Adelaide, and it will be held from 12th to 16th July, 1993.

The 20th conference would be in 1994 at the University of Waikato, with Les Foulds undertaking the organisation.
7. Election of office-bearers for 1993

The following office-bearers were elected unanimously:

Although there has been almost too much choice of talks during the week, we feel that the experiment of holding the meetings at a single venue is worth repeating (but not too frequently!).
