Minutes of the 19th Annual General Meeting of the

Combinatorial Mathematics Society of Australasia held on 13 July 1993

at the 19th Australasian Conference on Combinatorial Mathematics and Combinatorial Computing at The University of Adelaide, Adelaide SA

The meeting commenced at 4.25pm with Emeritus Professor Bernhard Neumann in the chair.

1. Apologies

Rey Casse, Cheryl Praeger.

2. Minutes of the 1992 AGM

These were circulated in the November 1992 CMSA Newsletter and reproduced for those attending the AGM. Subject to the spelling corrections Bernhard Neumann and Jennie Seberry, the minutes were confirmed (moved: Anne Street, seconded Liz Billington, carried unanimously).

3. Matters arising from the minutes

In response to a question on life membership by Derrick Breach, Helen Gustafson reported that the Society has 158 members including 15 life members.

4. Reports

- (a) The Director's report was presented by Christine O'Keefe and was received (moved Derrick Breach, seconded Bob Buttsworth). The report appears in full in this newsletter.
- (b) The Treasurer's report was presented by Ed Dawson. Ed asked that in future the subscription for the CMSA be included in the conference fee to help reduce administration and to ensure that fees are paid. For instance, many members have not yet paid their 1993 subscription. The report was received (moved Kevin McAvaney, seconded Anne Street) and appears in this newsletter.
- (c) The Membership report was presented by Helen Gustafson, and appears in this newsletter. A full list of members is available from QUT by anonymousFTP, which is updated monthly by Helen. The Society congratulates Helen for doing such an excellent job and the report was accepted with acclaim (moved Jennie Seberry, seconded Christine O'Keefe).
- (d) The Financial report of the Australasian Journal of Combinatorics was presented by Tony Moran and appears in this newsletter. The journal has 85 subscriptions (about 20 new this year with 5 cancellations) and members are urged to investigate ordering the journal for their library. The report was accepted (moved Jennie Seberry, seconded Rebecca Gower).
- (e) The Booklet Editor's report was presented by Kevin McAvaney. There are 3 booklets ready to print and 3-4 offers of further booklets. Kevin is at the point of making decisions about the numbers to print and marketing. The report was accepted (moved Anne Street, seconded R Aldred).

5. 1995 Membership fee

The treasurer Ed Dawson suggested that the fee remain at \$10 for 1995, and that this be collected at the 1994 conference. The motion was carried (moved Bernhard Neumann, seconded Kevin McAvaney).

6. Future conferences

The Hadamard Centenary Conference will be held in Wollongong from 6-9 December 1994. See the last newsletter for details.

The 20th ACCMCC will be held in Auckland, New Zealand, from 5-9 December 1994. Further details are given in this newsletter.

The 21st ACCMCC will be held at Deakin University.

7. Election of Office bearers for 1994

It was noted that this item is connected to item 9. However, it was decided that for 1994 we continue the practise of electing the next conference director as Director of the CMSA and empower the director to co-opt a committee. Therefore, Professor Peter Gibbons will be the director of the CMSA for 1994.

8. Review of ARC funding

The ARC held a review of the funding of the Mathematical Sciences during the period 87-91, in which some disturbing references to Combinatorics were made. It was agreed that the Society should write to Professor Max Brennan, Chair of the Australian Research Council, protesting the claims that combinatorics is overfunded in Australia. (This letter was signed by conference attendees and forwarded to Professor Brennan on 15 July. A response was received on 28 July. Anyone who signed the letter and would like to obtain a copy of the reply should contact Christine O'Keefe).

CMSA structure

The previous item led naturally to this one, which is prompted by several considerations. Firstly, it is becoming increasingly clear that the Society needs to have a stable and coordinated organisational body to adequately represent the interests of Combinatorics in Australia and New Zealand. Secondly, the Society should be incorporated to prevent the current situation that the members are individually responsible for costs arising from, for example, a lawsuit against the Society. These changes necessitate a revision of the constitution. A committee (Derrick Breach, Jennie Seberry and Anne Street (convenor)) agreed to draft a new constitution, circulate it for comment and present it for a postal ballot to take effect from December 1994. This motion was carried unanimously (moved from the chair, seconded Jennie Seberry).

10. Any other business

Kevin McAvaney proposed a vote of thanks to the organisers of the 19th Australasian Conference on Combinatorial Mathematics and Combinatorial Computing, to be conveyed also to the University of Adelaide, Lincoln College and the Royal Adelaide Hospital Residential Wing.

The meeting closed at 5.20pm.

Originally scheduled to be held at the University of Waikato, the 20th ACCMCC will now be held at the University of Auckland (City Campus) from 5 - 9 December 1994.

An enthusiastic conference organising committee consisting of Peter Gibbons, Peter Lorimer, Marston Conder, Paul Bonnington, Margaret Morton, and Paul Hafner has been formed, and is planning for a balanced program of contributed and invited talks covering a wide range of combinatorics. The committee is attempting to attract two further distinguished speakers. An announcement will be made about this later.

Accommodation has been booked at O'Rorke Hall, a modern student hostel within 5 minutes walk of the conference venue. Further details, along with details of registration and the social programme, will be published towards the middle of 1994.

The city campus of the University of Auckland is situated on a rise overlooking the Waitemata Harbour, only five minutes walk from the restaurant, shopping and entertainment facilities of the central business district. For the information of colleagues from more distant places, Auckland is antipodal to Malaga in Spain and is known as the "City of Sails". It has a population of close to one million and a climate moderated by the adjacent Tasman Sea and the Pacific Ocean. Besides using the city as a gateway to the rest of New Zealand, visitors to Auckland enjoy ready access to outdoor activities such as ocean swimming, tramping and boating. December corresponds to the start of the Summer holiday period in New Zealand, with daytime temperatures expected to lie in the range 16 - 23 degrees Celsius.
