Dates: Monday, 1 July - Friday, 5 July, 1996

Venue: University of Technology, Sydney which is located about a five minute walk from Sydney's Central Railway Station. In addition to the trains, bus services exist from most parts of Sydney to Railway Square.

Call for Papers: Contributed papers may be offered on any aspect of combinatorics. The time allocated will be 25 minutes for presentation and 5 minutes for discussion. Titles and abstracts of up to 200 words are requested and need to be received by 10 May, 1996. Abstracts can only be accepted on payment of the registration fee.

Registration: The registration fee will be \$AUD220 for members of the Combinatorial Mathematics Society of Australasia in paid employment. The registration fee will be \$AUD120 for members of the Combinatorial Mathematics Society of Australasia not in paid employment Non-members pay an additional \$AUD20 and this includes membership of the CMSA for the remainder of the year. The registration fee includes the conference dinner on Thursday, 4 July at Hotel Lawson. Registration at the conference will incur an additional fee of \$AUD100.

Accommodation: Because of the central location of UTS, it is possible for delegates to stay just about anywhere in Sydney. Some hotels near UTS offer discounts to delegates to UTS. These include the <u>Country Comfort</u> (\$AUD103 per night, single or double) and the <u>Hotel Lawson</u> (\$AUD100 per night, single or double). State that you are attending a conference at UTS when booking. Another alternative is the Sydney Travellors Rest Hotel(\$AUD89 per night double) which also has apartments that sleep up to 6 for about \$AUD140 per night. For those who prefer college accommodation, bookings can be made with The Women's College, University of Sydney. Single rooms with breakfast are \$AUD50 per night and twin rooms with breakfast are \$AUD90 per night. It takes 15-20 minutes to walk to UTS from Women's College. The organiser regrets that she is unable to arrange accommodation for conference delegates.
